

ACBL Unit 174 Annual Meeting Minutes

April 18th, 2021 Zoom

Call to Order Jack LaVigne

The meeting was called to order at 1:00 pm by Unit 174 President Jack LaVigne.

Jack welcomed, thanked, then gave Zoom participation instructions to the attending membership.

Jack said because there was not a quorum there would be no business done.

Minutes Joyce Gore

Copy of the 2020 Annual Minutes were made available on the Unit 174 Website which will be approved at another time.

Treasurer's Report Gary Hercules

A copy of the Unit's 2020 Financial Report was made available on the Unit 174 Website by Gary Hercules, Treasurer.

At the end of 2020, the Profit and Loss Statement reflects:

Income - \$193,463., Expenses - \$152,486. Net - \$40.977.

Fixed Assets - Zero Assets Purchased

Current Bank Balance - \$200,726.

Gary explained the Good Neighbor Program we have with Randalls, Safeway and Albertsons. If a member is signed up for this program a return of 1% of purchases is given to charity of choice (which may be Unit 174).

Jack thanked Gary, Treasurer and Patrick Tourais, Financial Verifier for taking care of all the Board's financials.

He then thanked Gary for all he does as Treasurer.



By Law Proposed Changes

Jack LaVigne

Jack reviewed the two (2) proposals for changes to the By Laws which will be voted on a future date.

1. Article VI Section 4, not really changing them, only changing the wording from:

A member may exercise one or more of the votes to which the member is entitled, and unexercised votes shall not affect the validity of votes that have been exercised: but a member may not cast more than one vote for the same candidate.

to

A member may vote for one, two or three candidates, but may only vote once for the same candidate.

Article IX Section 2, Rules and Ethics Committee: this needs to be removed as this has been moved from the Unit to the District by ACBL.

Old Business

Unit 174 Report Jack LaVigne

Jack gave a brief review of tournament participation of the table count for the years 2017 to 2020

The I/N Tournaments were held in January at Westside Bridge Academy and Bridge Club of Houston

Tournament Outlook Paul Cuneo

Paul gave an updated report that was issued April 15, by ACBL.

Paul said ACBL is busy planning the first initial post pandemic NABC in Austin.

He said ACBL is working on a software program for pre-registration for all tournament events and for the tournament itself.

Masterpoint Limited Sectionals and STaC will begin in August if local conditions permit.

Open Sectionals and Regionals will be evaluated on a case-by-case basis.

Paul then gave the ACBL's requirement (e.g. everyone must be vaccinated, masks are required, etc.).

Exceptions on vaccine and mask requirements will be considered on individual basis and will be due to qualifying medical conditions or firmly held religious beliefs. An ACBL representative or the Tournament Sponsor will make this determination.



Club Report Jack LaVigne

Jack displayed a chart of the table count for the four (4) online clubs and explained the increase of table count from March to December, 2020.

Jack informed the Board there are 2505 Clubs Nationally.

Each of the four (4) Unit 174 Houston Clubs made the ACBL Top 100 table count in 2020.

Westside Bridge Academy – 19th, Clear Lake Bridge and Galveston Clubs combined – 36th, BCOH – 26th, and Apple - 34th.

By way of Membership Statistics from April 2015 to April 2021 Jack said there was a slight increase from 2015 to 2019 about (1%), in 2020 a 3% decrease and in 2021 a 7% decrease

Jack said new member recruitment and member retention are the number one priority of the Unit Board.

Future Life Masters Greg May

Greg said Unit 174, and in fact, all of bridge has been suffering from a reduced retention rate and slow growth of new members. The Board established an I/N Committee to find ways to address these problems.

Greg introduced the FLM Committee: himself, Kathy McDougall, Nancy Guthrie, Cindy Cox and Lauri Laufman, all of whom were involved in designing and implementing this program.

Each of these volunteers have additional special duties that they handle.

Kathy was instrumental in establishing beginner teachers – Lauri is Unit 174 Virtual Club Manager and runs and directs the 0-20 masterpoint Apollo game- Nancy is the Flight Commander who works with the Pilots and interfacing- and Cindy is the Co-founder and visionary idea person.

Greg introduced the three (3) flights and their Pilots:

Apollo (0-20mp) Pilot - Mary Ellen Vail Gemini (21-50mp) Pilot- Janice Hardcastle Discovery (51-100mp) Pilot - Betty Westbrook.

Greg thanked the many copilots that work with the Pilots and contribute to this program.

Bridge-In-A Day (BIAD)

Kathy explained that the I/N initiative was to recruit new members and maintain existing members.

Kathy said District 16 initiated two free one-day online workshops (Nov 2020 and Feb 2021) that were held to attract raw beginners and returning rusty players. She said Unit 174 was heavily involved in these workshops.

A list of online Teachers was provided for these new players so they would know where to go and could continue learning about the game



Jack asked "what could we do to recruit new members?"

Jack suggested, we all take the "Add a New Player Challenge" by reaching out to family/friends and peers and ask them to try bridge. Successful members can instruct them to contact Mary Ellen Vail at flm174.com or go to ACBL Website and there is a Learn tab with fabulous items for new players.
