The Unit's ending cash balance in 2019 was \$155,800. The Unit's ending cash balance in 2020 was \$200,726. The Unit's ending cash balance in 2021 was \$190,371

During 2019 Tournament attendance was down 10%. During 2020 there were no Sectional Tournaments and during 2021 Two STaC Tournaments were held. The Lone Star Regional Tournament was held in 2019 and 2020 but not in 2021.

During the period we added bidding boxes and a new projector to our Fixed Assets.

By Law Proposed Changes

Kaern reviewed the two (2) proposals for changes to the By Laws.

1. Article VI Section 4, changing the wording from:

A member may exercise one or more of the votes to which the member is entitled, and unexercised votes shall not affect the validity of votes that have been exercised: but a member may not cast more than one vote for the same candidate.

to

A member may vote for one, two or three candidates, but may only vote once for the same candidate.

Thomas Rush moved that we accept the ByLaw changes to Article VI Section 4.

Karen gave a review of tournament participation and the table counts for 2017 through 2021.

Tournament Outlook Karen Nussbaum

As of March 2022 per the ACBL masks are encouraged, vaccinations required for all staff and tournament attendees. Tables should be 8 feet apart and hand sanitizer stations and masks should be available for all. No food is allowed at the table during play and drinks must be covered. Exceptions on vaccine and mask requirements will be considered on individual basis and will be due to qualifying medical conditions or firmly held religious beliefs. An ACBL representative or the Tournament Sponsor will make this determination.

Club Report Karen Nussbaum

Karen displayed a chart of the table count for the three online clubs and explained the increase of table count due to BBO online participation. Face to face participation has decreased form over 1,000 tables per month just over 500 per month.

Membership Statistics from April 2015 to April 2022 reflect a decrease from 2,524 members to 2,320 members in April 2022. New member recruitment and member retention continue to be a top priority of the Unit Board.
