#### Call to Order

The meeting was called to order at 1:00 pm.

#### ACBL Up-Date

Paul addressed online cheating. He informed the Board there had been two (2) players that have been convicted and have confessed to cheating. Both have been suspended by ACBL.

There is over 60,000 members playing online and approximately 50 cases in the pipeline that are now being investigated for cheating. These are mostly new members and players that are playing from the same residence. With these facts, Paul stated cheating was not as rampart as players complain of.

Paul said there was a complaint about the quality of online Director rulings. He said it is a difficult position for the directors but agreed the rulings could be improved.

He said the contracts for future Regionals with the Marriot are close to being negotiated and finalized.

Jack said Paul had shared that at the end of September,2020 there were 1000 out of 2500 members of Unit 174 playing online. As of February,2021 there were 1400 playing online. Paul thanked the Board members for all the efforts they had made to obtain this increase and said we needed to keep increasing these numbers.
