ACBL Unit 174 Board of Directors Meeting

June 1st, 2009

Call to order

Eric Snow presented the final financial report of the March NABC. The bottom line showed a total of \$51,238 to be returned to the coffers of the Unit. Eric wants to consult with the Unit Treasurer, Jim Woodward, to see if any further detail is needed.

Eric also stated that the Houston Visitors and Convention Bureau was very helpful in making the NABC go smoothly. The Bureau helped us arrange for \$5 daily parking, provided shuttle buses for local restaurants, helped us prepare a restaurant guide, and helped to arrange tours. The cost of membership is \$100 per year.

Bert initiated discussion of a club request for reimbursement of the cost of a party for participants of a social bridge event.
