Call to order

- Net income YTD is \$9,184.21.

Betty Freedman's nine person committee is still working hard; 36 people were contacted last month either via telephone or post card.


Membership

Second year retention (65%) and the number of new members in the past three years (656) are both up.

It's pretty amazing that we've gone from a low of retaining only about 42% of our new members to 65% in the past seven years, but reaching 2,400 members seems to be tough. Hopefully the Social Bridge Initiative will get us there.

Bob reported on the September STaC. Fourteen clubs participated; the total table count was 548. Total expenses were \$2,422.87; total income was \$4,384.00; net profit was \$1,961.13.

Supplies

Lauri has been inventorying the supplies in preparation for the Social Bridge Event and the October sectional.

Bert has refurbished the tall supply cabinet: replaced all the hardware, rebuilt the table card holder, and painted the cabinet. Still needed are the replacement metal cabinets; Powers Industries ordered the wrong ones, and Bert had to get them to send them back and order the right ones. Hopefully, they'll be here in the next week.

Tournament Coordination

Pat reported that the Marriott isn't quoting the bridge rate for the Regional to at least some who call and request it. She will contact Becky Zendejas and follow up.

Also, people are inquiring about the upcoming 99'r and 299'r tournaments; there are as yet no online flyers for these tournaments. These need to be created so the ACBL can link to them.

Pat finalized credit card payment and gave the names of the directors to Regency Suites Hotel in Humble.

She also finalized the scheduling of all special events with the ACBL for 2009 and the Sectional dates for 2010.

Old Business

October Sectional

Paul and John are having trouble finding someone to do the catering for the October sectional. They have found someone to do it: this person will only do it if they are also allowed to cater the

Election Sectional

Lauri passed out a preliminary budget for the Election sectional to be held next May. The P&L for last April's tournament is still missing some cost items; she needs those to finalize the budget. She will bring a revised version to the November meeting for approval.

Motion: That we raise the Sunday entry fees for the 2009 Sectionals to \$13/session to help defray the cost of the meal.

The motion was seconded and approved.

On-Line Partnership Desk

Bert is still finishing up some details. He thinks he's figured out how to modify it to handle requests for team games. Bert has been appointed District Webmaster, replacing Steve Bruce; that will make moving it to the district web server less of a problem. Bert plans to spend this week finishing it up; he'll ask Arlene to make it available as soon as he's done.

Contract for Head Caddy

Jim passed out a revised contract for the head caddy. The board felt that the terms of the contract should include words about "duties in accordance with the Unit procedures manual". Jim will make these changes and send a copy to Sandy Bippert for her signature.

Programs for Clubs

Joyce spent some time last month with Peggy Naughton of the Clear Lake club talking about Novice/Mentor and beginner game subsidies. Clear Lake is starting a five session fall mentor program as well as a Beginner game program. On Fridays evenings when there is not a Mentor game, they will hold a 0-20 game.

Marriott Renewal Contracts

Bert signed the new contracts for the annual Lone Star Regional on September 25th, after getting the hotel to revise the cancellation clause to be the same as in previous agreements. We now have a home for the Regional through 2015.

Sectional Tournament Sites

John reported that Bill St. Clair confirmed that the Berry Center does use all the available space for church services on Sundays until about 1:30, making this site unavailable for tournaments.

The University of Houston at Clear Lake has been proposed as a possible sectional site; Bob Dowlen will check into their facilities, availability and price.

John will recheck the conditions and cost of holding a tournament at the Sam Houston Race Park.
