From the Editors

We are excited to have the opportunity to send out the Unit 174 Newsletter. We have worked together for several years, identifying information that from the ACBL *Bridge Bulletin* that may be useful, especially to I/N players. The last few years of these monthly summaries are available here, on the WBA website.

Bridge Bulletin ARTICLE OF THE MONTH

January's article of the month is "Ask Jerry" on page 48. Jerry Helms presents two readers' questions with the same theme: making the best bid possible, even when that bid is not quite perfect. We would like to add a little context to this fine column.

For example, some players don't like to open 1N unless they have all the suits stopped, even if they hold 15-17 HCP and a flat hand. It's nice to have all the suits stopped, but even if you don't, you still need to open that hand 1N. It's just the most descriptive bid you have.

Question 1

In the first situation, right-hand opponent (RHO) bids 1H. The correspondent wants to know if a double promises four spades. No, it does not. It's great when you have four spades, because you would really like to find a 4-4 spade fit. If advancer (partner of the doubler) has four spades he should:

- 1. Bid 1S with 0-8 points
- 2. Bid 2S with 9- bad 12 points
- 3. Cue bid hearts with an a good 12 or more















However, the double promises only three-card support in the three unbid suits. So a fourth spade is desirable, maybe even likely (as partner didn't overcall a minor), but not guaranteed. Note that there is an exception to this promise. If partner has a 17+ point hand, he can double and bid a five-card or longer suit when he does not have three cards in the three unbid suits.

A related sequence that sometimes causes confusion is this (m = minor):

You LHO Partner 1m 1H X

This double (a negative double) shows exactly four spades; with five, partner should bid a spade. The difference between this auction and the earlier sequence is the number of unbid suits. There are only two in this sequence, not three. It would be nice if partner had both spades and the unbid minor. But having the unbid minor is not absolutely necessary, as long as there is a place to play (frequently the original minor).

Question 2

RHO opens a minor and the correspondent wants to double. Does this double promise four cards in both majors? No, it does not. As stated in the earlier question, a takeout double promises only three cards in the three unbid suits unless the doubler has 17+ points.

Yes, it would be great if the doubler held four cards in both majors, as we would like to find a 4-4 major suit fit. In response to a takeout double, we will usually bid our four-card major (we will jump with 9-bad 12 points as before). We will cue bid the opponent's suit if we have an opener.

The main point of the article is that we cannot let the perfect bid be the enemy of the good bid. If our bids are too restrictive, we won't get to use them as often as we should and we will end up making weak bids when we don't have a bid to describe our hand.


















THE DOUBLE-EDGED PREEMPT

Players preempt because it works. When the opponents have the majority of the points we want to take away as much bidding space from them as we can and we want to make them guess. However, bridge is a game of statistics and good bids and/or plays are not always rewarded. Sometimes they are penalized. This is a deal where a perfectly normal preempt backfired.

The Auction: P-1D-3H-X | P-3S-P-4S

South's hand is not the greatest opening hand, but it is an opening hand.

We like West's 3H bid in this position. Partner has passed, making game unlikely. West has a nice heart suit, and likely only two defensive tricks (the aces).

At this level, North's double suggests four spades, an opening (or near-opening) hand and support for the other suit (clubs). North can also tolerate a return to diamonds by partner.

South's 3S is imperfect, but the best option. Of course South would prefer to have four spades. However, South cannot pass the negative double with the J7 heart doubleton. South could bid 4C, but that might work out horribly if North has only three clubs; they would be in a part-score at the four-level. Better to be in a part-score at the three-level with a 4-3 (Moysian) fit. So 3S it is.

North, not knowing exactly what South does and doesn't have, raises spades. Besides, he doesn't have to play it.

The Play

Defense takes the first two heart tricks and, at trick 3, East returns a club to West's A. West then leads another club, won by declarer. At this point, declarer would normally play the three top spades, hoping either for a 3-3 split or for the SJ to drop. However, since West preempted 3H, showing a likely seven hearts, and has already shown two cubs, it is unlikely that he has the SJ. So, instead of playing for the drop, South finesses against East to make the 4S contract.















The way to defeat 4S is a bit counter-intuitive. It is almost always incorrect to give declarer a ruff a sluff because it presents declarer with an opportunity to get rid of a loser he might otherwise be stuck with. However, giving declarer and ruff and a sluff is the way to beat this contract. East needs to dump the HK under partner's ace. West next wins the HQ and plays a third heart.

South would trump the third heart in hand (on the short side) and take four spades tricks, finessing against the SJ. South would also get the four top diamonds. So... four spades, four diamonds and a ruff comes to nine, not ten, tricks. When South goes after clubs, West would rise with the CA and lead out the rest of the hearts. Declarer, out of trump, cannot stop the hearts. The key to defeating 4S is to keep the CA in West's hand to be used as an entry to the hearts after all the trump have been played.

If you find yourself playing against opponents who can find this defense, we suggest you ask them to become your teammates.
